- Update on resolving receipt of failed 2017 Cupid Cherry plants Debbie
 - Bron & Sons agreed to reimburse the 76 plants that reportedly died shortly after arrival;
 - Debbie has ordered 100 Cupid's for spring 2018 delivery and availability to replace the same number that were lost;
 - Several questions about who would be eligible for the new cherry plants, the cost, the reimbursement for previous orders, etc.
 - Motion to refund the cost of the Cupids to those who reported dead ones; Moved by Mike Tabled by Doug for the new Board to make recommendations and for action after more is known
- Plant Orders Debbie, Joe
 - Now accepting pre-orders for Malus baccata root stock order;
 - Debbie has pre-ordered 1300 root stock for delivery spring 2018;
 - 300 will be reserved for the spring grafting workshop; remaining available to the membership
 - The order is for 1/4" root stock that is correctly sized since last year's order seemed to be rather small in caliper size
 - Please email Debbie if anyone wants to order additional types of plants
